



As we have learned in the last several years, the world is a smaller place than we think and aesthetic plastic surgery can bridge many divides

Currently, we are working on a collaboration for a meeting in Dubai as well as expanded research opportunities.

The meeting in Miami Beach was a smashing success. We had 2,088 attendees plus 1,400 industry representatives. Fun networking and learning was had by all. And, the Business Meeting saw the induction of two female presidents with Dr. Caroline Glicksman as ASERF President and me as President of The Aesthetic Society. We are excited for a great year of collaboration and growth for both The Aesthetic Society and ASERF.

This will begin at our "Nuances in Injectables" meeting, set for January 12, 2024. There are now "30,000 injectors in the US with industry looking to quickly on-board at least 10,000 annually to meet the rising demand. This is demand that as plastic surgeons we cannot begin to meet alone. As leaders in education and patient safety it is important that we take a leadership role in their training. We have trained our own injectors for years, we just need to help train more.

Patient Safety Advisory—Breast Implant Removal and Capsulectomy

There has been a worldwide increase in the number of patients requesting implant removal for a variety of systemic symptoms that they attribute to their implants. This has been referred to as Silicone Incompatibility Syndrome (SIS), Autoimmune/Inflammatory Syndrome Induced by Adjuvants (ASIA), and Breast Implant Illness (BII).1 In the US, the Food and Drug Administration (FDA) has included systemic symptoms in a box warning that is required for all implants sold in the US which states, "Patients receiving breast implants have reported a variety of systemic symptoms such as joint pain, muscle aches, confusion, chronic fatigue, autoimmune diseases, and others. Individual patient risk for the development of these symptoms has not been well established. Some patients report complete resolution of symptoms when the implants are removed without replacement."2

Patients with self-described symptoms request removal of the implant and capsule, "en bloc." Their concern is that toxins from the implant, such as heavy metals, including platinum, silicone, and/or bacteria and fungus, could be in the capsules and failure to remove the capsule would leave toxins behind and could preclude symptom improvement. For that reason, they seek out surgeons who guarantee total en bloc capsulectomy and this is perpetuated on some social media sites as well as by surgeons who promote themselves as "explant experts."

WHAT WE KNOW

- Systemic symptoms patients attribute to their breast implants have been reported with all types of implants: saline and gel filled, smooth and textured surfaces, and has been reported with implants from every manufacturer
- Over 100 symptoms have been reported, in no specific configuration.
- Some patients will experience symptom improvement with implant removal.

WHAT IS THE DATA?

The Aesthetic Surgery Journal has published four papers from an ASERF-funded study, "Systemic Symptoms in Women-Biospecimen Analysis Study." This study, with Drs. Caroline Glicksman and Patricia McGuire as principal investigators, is the first prospective, blinded study comparing women with self-described BII to two control groups. The study evaluated symptom surveys, NIH-validated patient-reported outcome measures, and biospecimens (peripheral blood and implant capsules) for consistent, objective, measurable differences between the symptomatic cohort and the two control groups (women with implants without systemic symptoms they attribute to their implants, and women undergoing cosmetic mastopexy who have never had any implanted medical device) which could be used to make a diagnosis or point to a cause of symptoms in these patients.4-7

- The self-described BII cohort reported statistically significantly higher symptoms at baseline from the two control cohorts.
- 2. The BII cohort experienced rapid symptom improvement after implant removal which was sustained through one year of follow-up. The symptom improvement was independent of whether part or all the capsule was removed. There was no statistical difference in reported symptoms between the two control groups at any time point.
- There was no measurable difference in the biospecimens between the cohorts including heavy metals testing and next generation sequencing (PCR) for bacterial and fungal DNA of the implantsurface or capsule.
- 4. Recently presented data from a parallel study in Australia, with Drs. Anand Deva and Mark Magnusson as principal investigators, has shown similar results with symptom improvement after implant removal, independent of the type of capsulectomy performed.8

5. A study by Byrd and Nissen in the Netherlands prospectively followed patients undergoing implant removal and showed that symptom improvement occurred even with no capsule removed in subjects with no other indication for capsulectomy.⁹

TERMINOLOGY IS IMPORTANT

- The term en bloc describes a procedure for malignancy where a tumor is removed with a margin of uninvolved tissue. This term should not be used for a capsulectomy performed in the absenceof malignancy.¹⁰
- The often self-reported term BII implies a causation by breast implants when there is currently no direct evidence of causation, only a potential association. A more accurate characterization would be to use the term "Systemic Symptoms Associated with Breast Implants (SSBI)."

WHAT DOES THIS MEAN FOR PLASTIC SURGEONS AND FOR OUR PATIENTS?

As board-certified plastic surgeons, we should practice evidence-based medicine. The absolute indication for en bloc capsulectomy is removal of an implant and capsule in the presence of capsular malignancy. Relative indications for total capsulectomy are capsular contracture, rupture of a gel implant, and possibly with removal and exchange of textured implants. There is currently no good peer-reviewed evidence that capsulectomy is required for symptom improvement in the absence of other indications. Patient preference may be considered with appropriate informed consent. Capsulectomy is a more invasive procedure, may be more expensive, and may carry higher risks.

 Surgeons who state that en bloc capsulectomy is required for symptom improvement should not do so without the scientific data to support their claims and potentially violate ethical standards, as it could lead patients to undergo surgical procedures that may not be indicated.

Joint Safety Statement of the International Society of Aesthetic Plastic Surgery (ISAPS), The Aesthetic Society, and The Aesthetic Surgery Education and Research Foundation (ASERF)

- Surgeons promoting themselves as "explant experts" who have no additional training or other basis to deem them more of an expert than other board-certified plastic surgeons, should cease marketing themselves as such.
- Surgeons should keep abreast of scientific knowledge (AMA Principles of Medical Ethics).
- Surgeons should not falsely represent a skill set; ASPS Code of Ethics G-9: Contains a representation or statement of opinion as to the superior quality of professional services which is not susceptible to verification by the public or contains a statement representing that the Member possesses skills or provides services superior to those of other physicians with similar training unless such representation can be factually substantiated.

SSBI remain a diagnosis of exclusion so patients should have an appropriate medical evaluation to rule out other causes prior to surgery. Patients should be given educated choices using up-to-date, scientific data including removal of their implants with or without capsulectomy with the risks and benefits fully explained. It is likely patients will see at least partial symptom improvement after implant removal and their improvement may occur with partial capsulectomy, or no capsulectomy. Further prospective research is necessary, and guidance may change as more data becomes available.¹²

SAFETY INFORMATION FOR PATIENTS

- Breast implants are not lifetime devices and require regular follow-ups with your plastic surgeon.²
- Implant integrity should be evaluated with high-resolution ultrasound (HRUS) or MRI five years after implant placement and every 2–3 years after.²
- Any persistent symptoms that occur in patients with breast implants should be evaluated for other medical diseases prior to consideration of undergoing implant removal surgery.

- 4. For patients who develop symptoms that they attribute to their breast implants, if no other cause is found, it is likely that they will see at least partial symptom improvement after implant removal. The symptom improvement may occur with no or partial capsulectomy which is a procedure that is less invasive, less expensive and may carry lower risk.
- 5. Patients should seek out board-certified plastic surgeons for any concerns with their breast implants.

She started with acrylics and our teacher introduced us to oils. Just recently we picked up some watercolors to try!


Anything else you would like to add?

Cybersecurity: Prevent, Detect, Respond

Society is becoming desensitized to cyber breaches. Despite this, the threat is real. Grant Stevens, MD, our own past president of The Aesthetic Society, experienced a cyber takeover of his practice 2 years ago. "I was shocked to find out that I was hacked," says Dr. Stevens. "It cost me over 1.3 million dollars to remedy." The concern is that the normalization of these repeated news reports may lead to complacency about one of the most important aspects of a plastic surgeon's practice: the protected health information (PHI) and photographs of our patients. PHI is essential for treatment, and the integrity and availability of these data is part of the basic guarantee we have with our patients for safe and efficient care.

As recently as 5 years ago, many plastic surgeons kept their records in paper form. Today, however, almost all plastic surgeons have migrated to digital electronic medical records either because of government mandates or for improved convenience. However, along the way there has been no clear roadmap as to how to build a digital system, monitor it, or ensure that the data are encrypted and protected. In the United States, the Health Insurance Portability and Accountability Act (HIPAA),1 which was instituted in 1996, describes guidelines and best-practice techniques for data storage and retrieval.^{2,3} The National Institutes of Standards and Technology (NIST) has created a strategy,4 but it lacks explicit, practical implementation details for how the healthcare industry can build and maintain a resilient, protected digital system.

At each level of data collection, we encounter the conundrum of dichotomist goals. On the one hand, we demand privacy protection for our patients' photographs, medical health records, and financial information. On the other hand, we need access to these data across multiple platforms to provide medical care. Firewalls, encryption, complex passwords, and multifactor authentication techniques are deployed to secure access to our systems; however, these modalities also add to the workload and frustration level of accessing PHI. At a fundamental level, the challenge becomes a balancing act between security and usability. Any increase in efficiency for access may

compromise security and any increase in security may complicate access. Trade-offs are made, often without an understanding of their risks and implications.

In 2022, according to the Data Breach Investigations Report (DBIR), published annually by Verizon, in healthcare alone there were 849 incidents reported, 571 with confirmed data disclosure, 46% of those leaking PHI. "Healthcare has increasingly become a target of run-of-the-mill hacking attacks and the more impactful ransomware campaigns." The Guardian reports that The number of ransomware attacks on US healthcare organizations increased 94% from 2021 to 2022.

One of the greatest shortcomings of PHI security is our own interface with the internet through email. A long-standing axiom within the field of information systems is, "People are your weakest link." Your employees are still causing breaches, but they are 2.5 times more likely to make an error than to maliciously misuse their access.⁴ Phishing schemes are becoming more sophisticated and harder to detect, while at the same time our reliance on email connectivity becomes more essential to

our financial and fiduciary responsibilities.
Educating employees about phishing
schemes and other attempts at social
engineering to break into the PHI network is
one of the most vital prevention measures.
Every practice optimally would have an
information technology (IT) consultant who is
responsible for updating antivirus software.
These companies have invaluable resources
to help educate staff and practitioners on how
to avoid inadvertent opening of malware from
malicious cyber actors. There are multiple
levels of engagement with IT companies that
can be tailored to meet your individual needs.

The Aesthetic Society hosted a cybersecurity webinar 5 years ago (which is available at https://radarresource.org/search/cyber).

During the webinar Bob Aicher, who was the legal counsel for The Aesthetic Society for over 30 years, made the comment that, "Cyber breach is not 100% preventable." At the time, I was horrified at his assertion, but he is correct. Just as we strive to attain a 100% no-complication rate with our surgery, we know that this is not possible.

A SIMPLE, 3-STAGE FRAMEWORK THAT CAN HELP—PREVENT, DETECT, AND RESPOND

Prevent

The key is to identify the high incidence of risk and minimize it with preventative or prophylactic technical measures and/or transfer it in the case of cybersecurity insurance. As an aside, the litany of items in the application form for that insurance will itself force a realization about any shortcomings that currently exist in the practice's security status.

However, just as we are vigilant about early identification of wound complications, we should be vigilant about early detection of cyber breaches. Currently, IBM research shows that cyber breaches on average exist for 212 days before detection. Most medical malpractice companies provide some basic cybersecurity insurance; however, the amount of coverage is very minimal compared with the average cost of remediation from a cyber breach.

Detect

This requires proper and detailed instrumentation and logging of your systems beforehand and, most effectively, is combined with a specialized information security team that operates a security operations center which is constantly (24 \times 7 \times 365) watching that telemetry and actively hunting within it for indicators of compromise or threats by malicious actors.

Respond

The scale and duration of the response to remediate the breech is dictated by the sophistication of the attack and how significantly the platform has been compromised. This will require expert assistance—both legal and technical—and encompasses everything from isolating and removing the malware if possible, or recovering through the restoration of backups, to ensuring the integrity of your electronic

medical records and everything in between. Patient notifications and system downtime may be required, leading to significant reputational and/or financial losses. Of course, just like prophylactic measures in surgery, a little bit of education and early intervention can prevent a catastrophic outcome.

As we learn more about cybersecurity, we must become more facile with some of the new terminology to achieve heightened levels of security—terms such as "blockchain" which would recognize users and authenticate their trust and allow them access to secure files, or "zero trust principles" which would verify but never trust users and thus allow companies to prevent threats and filter them out of their system.8 Our patients expect us not only to know about the latest techniques in surgery, but they also demand that we are facile with, and utilize, these up-to-date techniques to deliver the optimal results with the shortest recovery. Is it too much to ask that we also employ the same degree of effort in the protection of their PHI and their photographs?

While the task of creating a cyber-secure practice may appear daunting, it does not need to be. By partnering with a strong IT company and cyber insurance group, you can begin to build a cyber-resilient platform that can manage data while simultaneously monitoring for unauthorized intrusions and then seamlessly resolve any breaches.⁹







The State of Aesthetic Fellowships Endorsed by The Aesthetic Society

Postgraduate fellowships in aesthetic plastic surgery offer advanced training in surgical and nonsurgical aesthetic procedures and unique mentorship opportunities. This training provides a focused experience in aesthetic medicine and surgery that allows fellows to significantly increase their fund of knowledge and surgical skills. An additional year of training also comes with a significant price both in terms of time and cost of compensation which may dissuade some residents from applying. This might represent short-term thinking if the opportunity cost of

an extra year of training is offset by greater long-term earnings. Therefore, it is imperative that every effort is made to enhance the quality of these fellowships, in turn making them an invaluable experience.

In the 2017-2018 application cycle, aesthetic plastic surgery fellowships joined the SFMatch. This effort was initiated by The Aesthetic Society to make application more user-friendly by simplifying, organizing, and centralizing the process. Fellowship directors applied for "Endorsed" status to participate and committed to a comprehensive 12 month curriculum. Although the number of aesthetic fellowship spots has more than doubled in recent years, there has not been a standardized governing body in place to oversee the quality of the education offered by these fellowships. Recognizing this gap, an Endorsed Fellowship Task Force was created to focus on enhancing and standardizing the quality of existing programs. The task force initiated a fellowship survey through which aesthetic fellows have anonymously provided constructive feedback. The feedback has helped to identify the strengths as well as weaknesses that are targeted areas for improvement.

The Endorsed Aesthetic Fellowship Task Force presented their recommendations on a wide range of quality initiatives that were approved by Board of Directors in June. These include operative minimums, surgical autonomy during the fellowship year, uniform minimum salary of \$70,000/year plus benefits, standard vacation time, required meeting attendance (The Aesthetic Meeting plus one additional), and participation in a formal webinar series. Finally, efforts are underway to assure transparency of individual fellowship experience by posting graduating aesthetic fellows' operative logs on the aesthetic society website. Consideration for an endorsed fellowship oversight/evaluation process and review committee is also under discussion to monitor the quality of the educational experience.

By standardizing the quality and metrics, the postgraduate aesthetic education will not only be enhanced but will also increase the intrinsic value of the extra year of aesthetic training. Watch for additional details in the next issue of "Aesthetic Society News."







Mark Jewell, MD, a Past President of The Aesthetic Society and his wife, Mary Lind Jewell, RPT, recently established the ASERF Patient Safety Award with a \$25,000 donation to the Aesthetic Surgery Education and Research Foundation.

When a member of the Major Giving workgroup called upon the Jewells and asked them to consider making a donation similar to his own, they did not hesitate in their response. Within an hour of being contacted, they called the ASERF Development Office to discuss their giving intentions and specific goals to sponsor an award.

Upon approval of the Board of Directors, ASERF created a fund and established The ASERF Patient Safety Award which recognizes an individual(s) who has made a meaningful contribution to improve the quality and safety of aesthetic plastic surgery and cosmetic medicine through innovation, process engineering, operational excellence, and research.

"When Mary and I were asked to make a significant donation to ASERF we wanted to make sure the gift was appropriate and meaningful. Establishing an award that recognizes patient safety made the most sense," noted Jewell. "I have been actively participating in research since the 1970s and patient safety is a core tenet of my practice philosophy. There is a science to patient safety, and individuals who make advancements here deserve recognition."

Dr. Jewell has held many volunteer positions with more than half-dozen plastic surgery organizations, including serving as President of The Aesthetic Society. His dedication to patient safety is recognized in both PRS and ASJ. He has achieved the longest reported patient safety outcome data in the world of zero perioperative infections in 45+ years of performing breast augmentation.

This forum gave the audience the opportunity to see the consistency of certain techniques. Additionally, the surgeons analyzed their post-operative results in front of the audience, which was a very useful exercise for residents. While the results were all amazing and the patients were clearly satisfied with their outcomes, the analysis by the surgeon and moderators is what plastic surgery is all about. As a resident with a particular interest in aesthetic surgery, the analysis of minute details is the difference between a great and superb result. I also found the All-Inclusive Courses particularly useful where a surgeon went through their thought process on a particular procedure or how to treat a specific problem. Overall, it was an incredible meeting and one that will forever change the trajectory of my future practice!

With just under two months left in my fellowship, I have been very fortunate to see almost the entire catalogue of cosmetic

procedures performed by a very experienced surgeon. Like most surgeons, my mentor has developed his craft over time and has honed his particular surgical routines from which he rarely deviates. Having no independent cosmetic experience of my own from which to draw, I naturally assumed that his approaches to various cosmetic procedures would be shared by most experienced surgeons. The 2023 Aesthetic Society meeting, however, opened my eyes to just how many different ways there are to approach a particular cosmetic endeavor.

I was struck by the variety of factors that influence how a cosmetic surgeon crafts the operations they offer patients. It's clear that today's master surgeons have stood on the shoulders of giants before them, employing the same basic principles even the youngest of surgical trainees continue to learn. Beyond fundamental technique, however, the procedures a cosmetic surgeon offers is shaped by many factors including their "average" patient demographic, their practice location and popular trends within that location, the resources available to them as surgeons and of course the continual feedback and critical evaluation their experience affords.

It is for these reasons that so many different approaches to common cosmetic procedures have been developed. Having the opportunity to learn from so many experienced cometic surgeons in one setting opened my eyes to this fact and reminded me of the reason I love cosmetic surgery, namely the creativity and ingenuity it embodies.

My most important learning experience at The Aesthetic Meeting 2023 was derived from the Breast Augmentation —Beyond the Basics session. It was amazing

to hear how true masters of the craft approach the same problem in different ways and achieve fantastic durable results. The session included detailed descriptions of submuscular, subglandular, subfascial, transaxially, and endoscopic operative techniques for breast augmentation. It also included intraoperative videos as well as pre and post operative photographs. The session was moderated by Dr. Adams from Dallas who made it a point to ask tough and revealing questions to each of the panel participants highlighting difference in techniques and rational for why they perform the surgery the way that they do. The key learning point that I took away from this lecture is that all these techniques can provide excellent results and that patient selection as well as joint decision making between the patient and the physician is key to a successful operation and a happy patient.



How to Hire and Recruit the Best Team for Your Practice

When someone gives their notice, is let go from a position, or a need arises to hire additional team members, we often see plastic surgery practices make the mistake of jumping into the hiring process too quickly.

This is especially true when someone leaves with very short notice. While it's tempting to put an ad online immediately to fill the position, you will save yourself both time and money in the long run if you follow key hiring and interviewing guidelines.

WHAT YOU SHOULD KNOW BEFORE YOU BEGIN

Before you rush to advertise a job opening, it is important to consider your long-term plan. Take a bit of time up front to reflect on the following questions:

What is your mission and vision for the business and what type of personality traits and skill set do you expect them to have to fit into your culture and perform the functions of the job?

- What is your growth plan for practice growth in the next year?
- How will your new hire contribute to the growth and client experience?
- What level of training will you provide this new hire to ensure they meet the demands of the position and are an asset vs. an expense?
- What specific qualities or qualifications and personality traits are needed for the role to be a good fit?

Finding quality people often takes time. We encourage you to take some time to think about and/or to speak with the rest of your team to determine some of the strengths and weaknesses of the previous employee and what skill set the position needs. Then, discuss what you are looking for in a replacement. Often it is better to hold out for the right chemistry, qualifications, and attitude, than rush into hiring someone who is not a good long-term fit.

11 Critical Factors to Consider:

- What responsibilities would you like this person and role to take on?
- Are clear expectations set forth and defined with a proper job description?
- What personality traits match the position?
- Is there a defined career path or room for advancement?
- Is there someone internally who might be a good fit for this position or would like to move into this role?
- What is the compensation range for this position?
- What training will be provided to ensure they are set up for success?
- Is the training once or ongoing?
- Will they be given goals and metrics to hit?
- How will you hold them accountable?
- Who will they be reporting to?

THE INTERVIEW PROCESS

We recommend you start with a 30-minute phone/zoom interview as a meet and greet and to find out the basics. You can normally tell within a few minutes into the call if it's a good fit just by personality. In addition, you will learn more about their background, alignment with the role, availability, skills related to the job, and compensation requirements. If basics check out, you can schedule a more in-depth personal interview.

There is also a lot of value to a working and team interview as a final step. It allows you to see in real time how they act, their level of resourcefulness, sense of urgency and how they learn.

A team interview reinforces a sense of ownership and teamwork among your current staff and must be structured and guided, so it is not intimidating. Create a list of questions as a team and allow time for the candidate to ask the team any questions they may have.

High Fives on the Consultation—But...Where Did the Patient Go?

By Karen Zupko

The majority of plastic surgeons would likely give themselves high marks in their consultation content, style, and approach. We will assume their self-objectivity is accurate.

Question: If in fact, the consult was brilliant, why do patients disappear without scheduling?

Answer: Their subsequent meeting with the patient coordinator included obstacles—spoken or unspoken that were left undiscovered, or if exposed, went unanswered.

What is an obstacle? It is anything the prospective patient says or does that prevents a successful scheduling conversation. Often, a patient's hesitation or comments are misunderstood as objections instead of a plea for clarification. It is crucial that the patient coordinator stops talking, actively listens, and responds with appropriate questions and understanding to alleviate a patient's reluctance to proceed.

In the absence of clarification, it's easy to see how a tremendous amount of time and energy could be spent on the wrong issue, or worse, give the patient something new to be concerned about. The secret is having an arsenal of open ended questions and "echo" responses ("I hear you." "I understand you.")

Here are four main obstacles you are likely to encounter: Let's role play on...

INABILITY—PATIENT LACKS BUDGET OR PERMISSION

Patient: "I want to have the procedure, but my husband isn't 100% on board."

PC: "I understand. That's a very common situation. Dr. Wonderful is always open to a complementary follow up consultation where your husband can join you. Often, the husbands leave feeling good once they meet him in person. When can we schedule that next step?"

MISUNDERSTANDING—ALL THE INFORMATION THE PATIENT WANTED WASN'T VERIFIED

Patient: "I'm not sure I can take 2 weeks off to recover."

PC: "I get it. You have quite a demanding job. There are a couple of options for you to

consider. We can either see if there is a less invasive alternative for you with minimal downtime, or perhaps we can do it over a holiday where you have more flexibility. Would either of those work?"

CONCERN—A LEGITIMATE CONCERN ABOUT THE PROCEDURE

Patient: "I've heard that a tummy tuck is the most painful surgery."

PC: "That is certainly a common concern, but our practice does a great job anticipating and managing pain. Dr. Wonderful uses a special medication during surgery that blocks the pain for several days for a much smoother recovery. Here is a brochure on the medication I'm talking about. We can also let you speak to a recent patient who just recovered if you prefer."

DISINTEREST—THERE'S A DISCONNECT BETWEEN THEIR DESIRE AND THE RECOMMENDATION

Patient: "I understand the recommendation. It's just more than I was counting on doing."

PC: (echo response) "What I hear you saying is that although you agree, it's a bit overwhelming to add on the other two procedures?"

Patient: "Yes."

PC: "Let's back up and look at just doing the eyelift you originally came in for. That will give you time to consider the rest another time. Next month we have 3 dates available. Which is best for you?"

As you might expect, there are hundreds of obstacles patients might voice. The point is, there is a formula to get to the patient's specific concern so you can solve it. Sometimes discovery takes several open-ended questions to identify the issue or issues. That takes practice.

Note that when details during a consultation or scheduling conversation become an unwelcome "surprise party" for a patient (e.g., fees, recovery, add on procedures) you might lose them altogether. And that's on you. Simple due diligence ahead of their first appointment can save you and them from an uncomfortable situation. Uncomfortable patients don't schedule.



Is Al Content Against Google's Guidelines?

Artificial intelligence (AI) has made waves in the digital world over the last several months. With OpenAI's ChatGPT, Google's Bard, and Microsoft's Bing, conversational AI tools are becoming more mainstream, causing many to wonder how online search will continue to change.

As these large language model (LLM) programs are quickly being integrated into our daily lives, it's important for plastic surgery practices to understand how AI content may affect SEO.

Earlier in 2022, Google Search Advocate Matt Mueller explained that Al content is considered automatically generated content and would, therefore, be treated as spam. The question of how well Google would be able to detect Al-generated content, however, was still unknown. As Al technology has become more sophisticated over the last year alone, Google has shared updated guidance on how they view Al-generated content.

GOOGLE RELEASES STATEMENT ON AI CONTENT

In its recent article, Google stated, "Appropriate use of AI or automation is not against our guidelines." However, the search giant clarified that while using AI tools is allowed, doing so to manipulate rankings is against their spam policies. Rather than banning all AI content from search results, Google has maintained its focus on favoring high-quality content, regardless of how it's produced.

This is a similar approach to how it handles the black hat SEO strategy of mass-produced human-generated content. Rather than banning all human-generated content, it refined its approach to rewarding the highest-quality content, which typically excludes duplicated text from content farms. As its Helpful Content Update took effect late last year, Google has put a major emphasis on content that's written for people, versus content that's written with the main goal of ranking well.

Despite whether content was created by a human or Al tool, Google has made it clear that high-quality, people-first content is what it

aims to reward. With the right motivation and SEO strategies, Al can be a valuable tool for helping to improve content for prospective patients.

GOOGLE'S ADVICE FOR USING AI-GENERATED CONTENT

Google has recognized that AI can advance our ability to provide helpful content for people, but it maintains high standards for what it deems to be quality content. As medical and dental practices consider the use of AI tools in their content efforts, it's important to follow Google's advice for demonstrating what it calls E-E-A-T: expertise, experience, authoritativeness, and trustworthiness. In addition, Google has encouraged content creators to think about the "Who, How, and Why." More specifically:

- Making it known "who" is creating the content, such as with background information or a byline.
- Being transparent about "how" the content was generated, and specifying if AI was involved.
- Understanding "why" the content is being created in the first place, which should be for the benefit of the reader.

By following these guidelines, content creators can increase their chance of being rewarded by Google with high search engine rankings.

WILL AI CONTENT TAKE OVER SEARCH RESULTS?

Al content written without carefully crafted prompts or the oversight of a subject matter expert will typically be low quality. Just as Google wouldn't favor a human-generated page of content that's not helpful to the reader, its systems shouldn't reward a page written by Al tools if there are higher-quality pages available. In the eyes of Google, content is content. If it's helpful, original, and follows the E-E-A-T guidelines, there's a chance it may perform well. If it doesn't satisfy these best practices, it likely won't rank high in search results.

Those using AI programs to write their content as a shortcut to ranking well will likely be disappointed by the results. However, those utilizing AI technology to improve the helpfulness of their content may find it can give them a boost. With the right SEO strategy and evaluation from an experienced human writer, AI can be a valuable tool for helping to inform prospective patients and rank higher in the process.

5 Shifts to Cosmetic Patients on Demand

It takes a different mindset to generate the preferred cosmetic patients you want, whenever you want, at the price you want so you are no longer busy being busy but not profitable.

ou just don't need the aggravation of spending more on advertising to attract a bunch of poor-quality leads that waste you and your staff's time when they don't show up or don't say yes to your services because they want to price shop some more.

Make these shifts to grow a steady stream of predictable revenues and lock out your competitors and make it impossible for them to steal your patients away because your patients are loyal to you and see you as the ONLY choice...

SHIFT #1: PATIENT CENTRIC VS. MONEY CENTRIC

When you shift your thinking from a "One and Done" money grab event to a "Patients for Life" mindset, you win the long game. So instead of thinking about your own bottom line and what's best for you, you think about what is best for your patients.

This shift in thinking changes your perspective as well as your attitude. You now see and treat patients as family and friends. They see your practice as a friendly haven. They trust you and your staff to take great care of them.

They reciprocate by growing your revenues for you by returning to YOU rather than your competitors. And by referring their friends, family, gym buddies, coworkers and neighbors.

And by giving you great online reviews that thousands of other potential patients see online. And by sharing you on their own social media platforms so THEIR followers get to know you and contact you because they're ready for your services.

Think of your cosmetic patients as your lifeblood to all you want in life... such as a fulfilling livelihood that affords you a comfortable lifestyle that supports your family, your interests and your financial future.

SHIFT #2: COMMAND PREMIUM PRICING

Stop discounting! You don't need to advertise specials to attract new patients because all you will attract are the WRONG patients who nickel and dime you to death.

So rather than discount, set higher standards for great customer service and processes, so your patients have a WOW patient experience every time that they gladly pay for.

And, then mirror behavior you want from those very patients because there is NO escaping cause-and-effect.

If you want patients to stop negotiating and gladly pay your FAIR prices—YOU stop negotiating and pay fair prices. And, if you want agreeable patients who are a pleasure to work with, be agreeable and be sure your staff be the same.

SHIFT #3: USE THE SECRET WEAPON

The traditional "hope & pray" method of attracting new patients is to spend a ton of money on lots of different marketing channels and then you hope it's money well spent and pray you get business from it.

The better way is to implement a loyalty/ rewards system that turns your existing patients into your raving fans. That increases their lifetime value, while they build your practice for you by returning, referring, reviewing, and sharing you on social media.

It costs 7X more to attract new patients than to retain existing patients, and loyal patients spend 67% more. Also, the average new patient conversion rate is 5%–20%, while the average existing patient converts at a whopping 70–90%. (Sources: SEMrush and ProfitWell)

SHIFT #4: RETENTION IS THE NEW ATTRACTION

Because of intense competition, the Internet, and social media, it has gotten increasingly more difficult, technical, confusing and time-consuming to attract new patients. So, retention has become the most direct route to more revenues.

It costs 7X more to attract new patients than to retain existing patients, and loyal patients spend 67% more. Also, the average new patient conversion rate is 5%–20%, while the average existing patient converts at a whopping 70–90%. (Sources: SEMrush and ProfitWell)

This is how you leverage your time with your preferred patients who are worth 10X more to you, and you stop wasting your time with those who nickel-and-dime you and then bolt for the next special deal from your competitors.

SHIFT # 5: INVEST IN EXPERTISE

Everyone should have a mentor or "counsel" that gives them new ideas, perspectives, and a plan to uplevel their growth and provide accountability.

Frankly, you need experienced counsel who can show you the shortcuts. Just like you invested in becoming a surgeon and learning from the best, you invest in marketing experts because trying to do it without proper counsel is crazy. The point is, don't go it alone.

Making these simple shifts will surge your revenues using the resources you already have, without advertising or discounting your services, while simultaneously increasing the number of patient visits, referrals, reviews and shares on social media.

OpenAl Will Change the Patient Experience: The Good, The Bad, and The Terrifying

Think chatbots on steroids and that is just the appetizer of how OpenAI is going to change the way you practice, and many other aspects of our daily lives. We just don't know how, and how much yet. In the fast-paced big tech world, we are just in its infancy.

f you don't believe me, have a look at what the ChatGPT platform pushed out practically in real time about 'The Aesthetic Society,' and where some early adopters may turn to learn more.

Do members of The Aesthetic Society have more training and expertise in aesthetic surgery than those from other organizations? ChatGPT:

- Reputation and Referrals: Research the surgeon's reputation within the medical community and among previous patients.
 Seek referrals from trusted sources, such as your primary care physician or friends who have had successful experiences with cosmetic procedures.
- 4. Continuing Education and Professional Involvement: Assess the surgeon's commitment to ongoing education and staying updated with the latest advancements in aesthetic surgery. Active involvement in professional organizations and participation in conferences and workshops can be indicators of a surgeon's dedication to their field.
- Personal Consultation: Schedule a consultation with the surgeon to discuss your goals, concerns, and expectations.
 This will provide an opportunity to assess their communication skills, professionalism, and whether you feel comfortable with them as your surgeon.

While membership in professional organizations like The Aesthetic Society can indicate a surgeon's commitment to their field, it is essential to evaluate each surgeon individually based on their qualifications, experience, and patient outcomes.

Membership alone should not be the sole determinant of a surgeon's expertise in aesthetic surgery.

This is not bad for a first attempt, but it leaves some lingering doubt for the reader to decipher. The last sentence may signal to prospective patients that they need to see many surgeons, and not necessarily members of this organization; "Membership alone should not be the sole determinant of a surgeon's expertise in aesthetic surgery."

ChatGPT and Bard are in their infancy, so what can be done with these platforms today will barely resemble what they may be able to do in the not-so-distant future. They will have plenty of time to keep making improvements along the way as the competition expands. ChatGPT creator Sam Altman, and some other tech wizards recently spoke to the Senate Judiciary Committee to bring them up to speed about the potential challenges and

dangers of artificial intelligence. According to Altman, "I think if this technology goes wrong, it can go quite wrong."

The flip side is that some of these platforms are already able to personalize at least some of the information they spit out to users. They could potentially present too many options to consumers that can confuse and distract them which could put them off their search. As of my writing this article (May 15, 2023), the technology available to consumers is not yet able to demonstrate emotions or empathy, which may turn off a patient who is looking for a facelift and needs more reassurance than a robot can provide.

My advice is to experiment with the key platforms and watch this space as it keeps changing and growing. For now, stay on top of the trends that are coming at us at the speed of light. Keep an open mind when innovations turn up that you are tempted to experiment with.

Even if you are anti-tech, there is no doubt that OpenAI is here to stay and will get more sophisticated in record time. We can't avoid it.

Highlights of the Consolidated Appropriations Act of 2023: Two of Many Retirement Planning Changes



The Consolidated Appropriations Act of 2023, enacted on December 29, 2022, includes the Secure 2.0 Act, which contains many provisions designed to expand retirement coverage, increase retirement savings and clarify retirement rules. Here is a synopsis of just two of the rule changes.



of significant interest is the increased age for required minimum distributions (RMDs). Prior changes raised the age from 70½ to 72. The new law increases the RMD beginning age to 73 for those born from 1951–1959 and to age 75 for those born in 1960 or after. While the RMD beginning age has increased, account owners will still be allowed to take Qualified Charitable Distributions (distributing retirement plan money directly to a qualified charity) at age 70½. Also, the penalty for a missed RMD has been reduced from the current 50% down to 25%.

A later beginning date for RMDs will allow taxpayers additional years for traditional retirement accounts to continue growing on a tax-free basis. It also means that participants have more time to convert traditional accounts to Roth accounts. In addition, the new Act eliminates RMDs for Roth 401(k)s and Roth 403(b) accounts beginning in 2024, so that Roth qualified plan accounts will have the same RMD treatment that Roth IRAs already have. For those retirees who don't need plan distributions for living expenses, a Roth conversion may be an option. In planning, however, keep in mind that most non-spouse beneficiaries of both traditional and Roth accounts are subject to a ten-year distribution rule for inherited IRAs.

529 TO ROTH IRA TRANSFER

Beginning in 2024, taxpayers with 529 plan balances will be able to transfer those balances to Roth IRAs. This provision, however, comes with several restrictions: The Roth IRA account must be in the name of the 529 plan beneficiary, and the 529 plan must have been maintained for 15 years or longer. Contributions to the 529 plan made within the previous 5 years (and the earnings on those contributions) are not eligible to be transferred. The lifetime maximum which can be transferred is \$35,000 and the annual limit for a transfer is that year's IRA contribution limit less any IRA contribution already made by the taxpayer in that year. Because the annual transfer amount is subject to the IRA limit, the beneficiary must have compensation. These transfers are not subject to the income limitations which prohibit high income taxpayers from contributing directly to a Roth IRA, but it is not yet clear whether a change of the 529 plan beneficiary re-starts the 15-year period.

CONCLUSION

Make sure to work with a professional advisor to understand how all of the new rules created by this Act may impact your planning, including many not covered in this short article. Know Your Insurance Carrier's Financial Strength

An insurance companies' financial stability is important to consider when selecting your medical liability carrier as they are responsible for claims that occur not only today but over a period of time which may encompass several years.



Rating companies typically focus on balance sheet strength, operating performance, business management and risk management when evaluating the financial stability of a liability carrier.

n the event that a liability carrier is unable to fulfill that obligation, you as the physician may become liable. Independent ratings agencies evaluate the financial stability of insurance companies. Financial Stability is an evaluation of an insurance company to meet all current and future insurance obligations.

Rating companies typically focus on balance sheet strength, operating performance, business management and risk management when evaluating the financial stability of a liability carrier. There are many factors that influence all four categories however three key indicators are net income, combined ratio and policyholder surplus.

Net income is a company's total earnings and is calculated by subtracting total expenses from total revenues. If the number is a positive, there is profit and if the number is a negative, there is a loss.

Combined ratio is a measure used by insurance companies to help determine their profitability. The ratio is calculated by taking the total of both losses and expenses and then dividing them by the premium. To make it a bit easier to understand, all you really need to know is that a ratio below 100 percent indicates the company is making an underwriting profit while a ratio above 100

percent means the company is paying out more in claims than the premiums it is accumulating.

Policyholder surplus is the difference between an insurance company's assets and its liabilities. In the simplest of terms, it's an insurance company's net worth.

In trying to navigate your way through an insurance companies' financial strength, you could consider how they are rated by any of the following: A.M. Best Company, Finch Investors Service, Moody's Investor Service, Standard & Poor's, Weiss Research, Inc. and Demotech, Inc. Ultimately if you do have questions about your insurance carrier's financial strength your carrier or your broker should be able to provide their rating information to you.

The Straight & Narrow—

Question

'm a plastic surgeon new in practice. A nonphysician has opened an injectables/fillers/laser practice in my community. She approached me and told me that she will send a lot of cosmetic patients my way. What's the catch

you ask?... In exchange, all I have to do is be the "Medical Director" for her office—which includes ordering and then reselling the injectables and fillers to her. I've got to ask... is this idea as bad as it sounds?

Answer

congratulations! You just won the trifecta—you get to supervise in absentia, compromise your own medical license if this practitioner is not qualified by the state—and you get to sell prescription medication to someone who does not hold a medical license (a possible felony).

What's crazy is how common this scenario actually is, whereby a "physician extender" without state licensure opens a spa to do injections. Often, the surgeon is invited to come in to see patients at a "higher rent rate" which, in return, buys referrals as a kickback. This is a huge "no-no" because it constitutes fraud in most states and collides with federal antikickback statutes. It's a lose-lose situation for all involved.

The measure of whether this situation is ethical might begin with its legality. Each state has its own licensure laws for physician extenders and the required level of supervision by a physician, so start there. Then move on to your medical liability carrier to verify how this arrangement would be covered—perhaps your provider offers "Medical Director" coverage. Keep in mind, however, that an instance of fraud or illegality would likely dismiss your malpractice carrier from liability and leave you vulnerable to a direct hit.

Some Aesthetic Society members have told me they purchase separate "Errors & Omissions" insurance, which can cost upwards of \$25,000 annually; this coverage is separate from the malpractice policy that covers their clinic—which is separate from a medical spa.

From a business standpoint, if you were to lend your name to this medical spa, do you think any of the other medical spas in the area will ever refer clients to you again? Many states allow physician extenders to inject on their own, but you must be sure about your required level of supervision. For example, some states require that all patients treated with a laser must be seen by a physician prior to and during treatments. Shoddy practices could also violate the scope-of-practice laws for the nurse or physician extender as well. Some of us plastic surgeons successfully market ourselves by pointing out that they do all their own injections.



We have patients watch a brief video of the actual procedure and visualize and palpate types of implants (pros and cons of each), and obtain their consent to post on social media. Studies have shown this lowers stress, anxiety, postoperative complications, and unwarranted adverse events such as patient dissatisfaction, litigations and aggression towards the surgeon. Patient history and physical examinations are another vital component of preoperative assessments. This involves screening for common drugs and herbal supplements, and

diseases.^{13–15} Patients must be informed to stop taking certain drugs, and herbal supplementation for at least 2 weeks prior to the surgery as it is associated with increased bleeding.¹⁷⁻²⁰ Typical common drugs and herbal supplements are included in *Table 1*. Patients with diseases like diabetes mellitus are at an increased risk of postoperative complications, such as edema in their lower extremities, slower wound healing, increased rate of infection, myocardial infraction, rate of mortality and having a potential history of nerve damage and/or deficits in sensation.^{21–23} Hence, patients with diabetes mellitus do not make ideal candidates for silicone calf augmentation surgery as strong evidence supports, they are prone to acquire severe complications, and/or an increased mortality rate. Lastly, during the physical examination, it's important for the surgeon to measure the patient's calves to pick and order the correct size. These measurements are taken in two

places, first in the midportion of the calf. And the second, which allows the surgeon to assess the maximum length of the implant that can be used in the calf, is taken from the popliteal fossa (directly behind the knee) to the origin of Achilles tendon.²⁴

Lastly, the decontamination protocol begins 5 days before surgery. Specifically, the patient washes with chlorhexidine for five days and applies mupirocin ointment to the ear canals, intranasal region, nipple areola complex and the umbilicus to reduce the population of methicillin resistant staph (MRSA). It is used in order to effectively reduce the risk of surgical site infections (SSI's) leading to better overall patient safety and lowering the risk of complications. In the case of silicone calf augmentation, the calves must be prepped with chlorhexidine before any incision is made, as it tends to lower the chances of surgical site infection.²⁵

Pre-operative assessments significantly increase patient safety and lower risks. In the case of silicone calf augmentation surgery, a small subgroup of patients remain dissatisfied. These patients should have been screened for body dysmorphic disorder.²⁶ Smoking cigarettes and cannabis have deleterious effects on wound healing, and should be stopped two weeks before surgery. Furthermore, consumption of THC and or any form of cannabis, increases the need for intra-operative sedation, and can put the patient at higher risk and should be discontinued two weeks prior to surgery.27 Knowledge of anatomy is critical to avoid damage to the medial and lateral sural cutaneous nerves and the common fibular (peroneal) nerve. The latter nerve is the most important and can result in decreased sensation, numbness, or tingling in the top of the foot or the outer part of the upper or lower leg. Additionally, the patient may present with a foot drop or a "slapping" gate. Their toes may drag while they are walking and they may demonstrate weakness of the ankles or feet (Please see Figure 1). For convenience, I added a sample operative note (please see Table 2) which includes some of the sedation techniques which I recently wrote about in my article on Office Based Sedation with Dr. Brannon Claytor.²⁸

Enhanced outcomes can be achieved by performing composite fat grafting. This can be achieved by judicious placement of fat in the



subcutaneous tissue with an appropriate fat grafting system. Please see the videos embedded in the QRS codes below. Additional measures to enhance patient safety include the use of barbed suture material such as 2-0 Stratafix and using Poly-4-hydroxybutric acid (P4HB) to enhance the strength of the closure. Finally, I have recently been using the new device called Brijjitt. This is a force modulating tissue bridge, which has been shown to decrease breakdown of high

tension points during breast reduction and mastopexy by 80%. The early results with this are very encouraging. I have patients wear postoperative compression stockings for a minimum of four weeks to mitigate against deep venous thrombosis and decrease swelling. If there is no aspirin allergy, the routine use of 81 mg of aspirin for 30 days is recommended. Our overall goal with every surgery is improved patient outcome and improved patient safety.
